This major revision to United States Army publication, Army Regulation AR 600-20 Army Command Policy July 2020, prescribes the policies and responsibilities of command, which include the Army Ready and Resilient Campaign Plan, military discipline and conduct, the Army Military Equal Opportunity (MEO) Program, the Army Harassment Prevention and Response Program, and the Army Sexual Harassment/Assault Response and Prevention (SHARP) Program. This regulation implements DoDI 1020.03, DoDI 1300.17, DoDI 1325.02, DoDI 1325.06; DoDI 1342.22; DoDI 5240.22, DoDI 5240.26, DoDI 5505.18; DoDI 6495.02; DoDI 6495.03, DoDD 1350.2, DoDD 6495.01, DoDD 5205.16 and DoDD 7050.06. Also, it prescribes the policy and responsibility of command, which include the Army Ready and Resilient Campaign Plan, military discipline and conduct, the Army Equal Opportunity Program, and the Army Sexual Harassment/Assault Response and Prevention Program. The 30-day advanced publication requirement has been waived because the revision implements previously published law, DoD directives and instructions, and Army directives that need to be consolidated and communicated to the field as soon as possible. This regulation applies to the Regular Army, the Army National Guard/Army National Guard of the United States, and the U.S. Army Reserve, unless otherwise stated. It also applies to all assigned, attached, or operationally controlled U.S. Army Corrections Command personnel, and all Army Corrections System prisoners incarcerated in Army Corrections System facilities. Chapters 6 and 7 and appendix E apply to members of the Army National Guard of the United States when on active duty Title 10 orders, for 30 days or more. In all other cases, members of the Army National Guard are governed by regulations issued by the Chief, National Guard Bureau consistent with Chief, National Guard Bureau's authorities under 32 USC 110, 10 USC 10503, and DoDD 5105.77. It also applies where stated to Department of the Army Civilians. Portions of this regulation that prescribe specific conduct are punitive, and violations of these provisions may subject offenders to nonjudicial or judicial action under the Uniform Code of Military Justice. The equal opportunity terms found in the glossary are applicable only to uniformed personnel. AR 690-600 and AR 690-12 contains similar terms that are applicable to Department of the Army Civilians. Despite the efforts of both the U.S. Department of Defense and the Veterans Health

Administration to enhance mental health services, many service members are not regularly seeking needed care when they have mental health problems. Without appropriate treatment, these mental health problems can have wide-ranging and negative impacts on the quality of life and the social, emotional, and cognitive functioning of affected service members. The services have been actively engaged in developing policies, programs, and campaigns designed to reduce stigma and increase service members' help-seeking behavior. However, there has been no comprehensive assessment of these efforts' effectiveness and the extent to which they align with service members' needs or evidence-based practices. The goal of this research was to assess DoD's approach to stigma reduction, how well it is working and how it might be improved. To address these questions, RAND researchers used five complementary methods: (1) literature review, (2) a microsimulation modeling of costs, (3) interviews with program staff, (4) prospective policy analysis, and (5) an expert panel. The priorities outlined in this report identify ways in which program and policy development and research and evaluation can improve understanding of how best to efficiently and effectively provide needed treatment to service members with mental illness.

Prepared by the Office of the Chief of Chaplains, United States Army, this handbook provides a useful guide to the beliefs and practices of a number of religious groups. The role of military chaplains has changed over the past decade as Western militaries have deployed to highly religious environments such as East Africa, Afghanistan, and Iraq. U.S. military chaplains, who are by definition non-combatants, have been called upon by their war-fighting commanders to take on new roles beyond providing religious services to the troops. Chaplains are now also required to engage the local citizenry and provide their commanders with assessments of the religious and cultural landscape outside the base and reach out to local civilian clerics in hostile territory in pursuit of peace and understanding. In this edited volume, practitioners and scholars chronicle the changes that have happened in the field in the twenty-first century. Using concrete examples, this volume takes a critical look at the rapidly changing role of the military chaplain, and raises issues critical to U.S. foreign and national security policy and diplomacy.

This regulation, Army Regulation AR 165-1 Religious Activities: Army Chaplain Corps Activities June 2015, establishes the policies, duties, and responsibilities of the U.S. Army Chaplain Corps in meeting the Army's religious and moral requirements in support of Title 10, United States Code (USC) (10 USC), Department of Defense directives (DODDs), and Department of Defense instructions (DODIs), and Chief of Chaplains (CCH) requirements. The Army Chaplain Corps consists of all military and Department of the Army (DA) Civilian religious support professionals.

"The Army's force posture is out of balance, with a greater percentage of troops stationed in the United States than at any time since the late 1940s. This has forced an over-reliance on lengthy, continuous rotational deployments to achieve deterrence and assurance in theaters such as northeast Asia and Europe. This finding is based on a 9-month study assessing the costs and benefits of rotational deployments and forward stationing. This United States Army regulation, Army Regulation AR 840-10 Heraldic Activities: Flags, Guidons, Streamers, Tabards, and Automobile and Aircraft Plates July 2020, prescribes Department of the Army policy for unit and individual authorized flags, guidons, and streamers. It prescribes procedures for the display and supply of flags. This regulation applies to the Regular Army, the Army National Guard/Army National Guard of the United States and the U.S. Army Reserve. This regulation is required during mobilization. This regulation prescribes the design, acquisition, display, disposition, and use of flags, guidons, streamers, automobile and aircraft plates, and tabards by Department of the Army (DA) organizations and personnel. It is the authority for these items and their basis of issue. It also describes the flags used by the President, Vice President, officials of the Department of Defense (DOD), and the Chairman of the Joint Chiefs of Staff (JCS).
