International textbooks on infectious diseases and antibacterial chemotherapy are usually written for readers in North America and Europe. In many ways, they are not

appropriate for the problems encountered in developing countries. This book, in contrast, intends to define the rules of antibacterial chemotherapy practised under conditions of limited resources. It is meant for everyone concerned with the use of antibiotics in developing countries, including doctors, medical assistants, pharmacists, officials in health ministries, and medical students. Throughout the book, treatment recommendations are made for 1 antibiotics from the WHO list of essential drugs. For example, emphasis has therefore been put upon chloramphenicol as a stable, unexpensive and widely available oral agent suitable for the treatment of severe bacterial infections like septicemia and meningitis. So-called "international chemotherapy" with modern cephalosporins and acylaminopenicillins has been outlined for comparison. Since it is the aim of the book to base treatment recommendations on data from developing countries, many data on the etiology of common bacterial infections in developing countries have also been included. Most of the data are from African, English-speaking developing countries, but references have been made to the literature on South East Asia, India or Papua New Guinea, where appropriate. On the other hand, pertinent data were not available in every instance, so that several statements and recommendations had to be made as "best guess". The authors are aware of these imperfections and will welcome comments from the readers.

Polymers continue to show almost amazing versatility. We have always known that polymers could be used for trinkets, toys and dishes. Now, however, we are no longer surprised to encounter these adaptable materials in almost every place we look. We find them in our cars, tools, electronic devices, building materials, etc. The use of polymeric materials in medicine is also well documented in previous books by one of the Editors (Gebelein) and by others. Likewise, the use of

This report is the result of a three-year research program. It describes the chemical character of cellulose ethers as a general class of polymers and establishes an approximate ranking of the relative stability of each generic chemical subclass. Ranking

the thermal stability of the polymers with respect to color change and loss in degree of polymerization led to the conclusion that as generic chemical classes, methylcellulose and carboxymethylcellulose appear to be the most stable of the cellulose ethers. Water-soluble ethylhydroxyethylcellulose apparently also possesses good stability. Of questionable long-term stability are hydroxyethylcellulose and hydroxypropylcellulose. Ethylcellulose and organic-soluble ethylhydroxyethylcellulose proved to be of poor stability, potentially undergoing marked changes in twenty years or less under normal museum conditions. An important additional conclusion reached here, as well as in an earlier investigation, is that considerable variations in stability can occur within a generic chemical class from differences in the basic raw material, a natural product from plants, which is not a uniform, manufactured, chemical substance. Further variations can exist due to different manufacturing processes or commercial sources. Hence, commercial products must be evaluated individually to determine the most stable of a given generic type. Nonetheless, the authors believe the conclusions expressed here to be valid with regard to the relative stability of the generic chemical classes of cellulose ethers.
