

## Isizulu Exam Papers Grade 6

"Why are you learning Zulu?" When Mark Sanders began studying the language, he was often asked this question. In *Learning Zulu*, Sanders places his own endeavors within a wider context to uncover how, in the past 150 years of South African history, Zulu became a battleground for issues of property, possession, and deprivation. Sanders combines elements of analysis and memoir to explore a complex cultural history. Perceiving that colonial learners of Zulu saw themselves as repairing harm done to Africans by Europeans, Sanders reveals deeper motives at work in the development of Zulu-language learning—from the emergence of the pidgin Fanagalo among missionaries and traders in the nineteenth century to widespread efforts, in the twentieth and twenty-first centuries, to teach a correct form of Zulu. Sanders looks at the white appropriation of Zulu language, music, and dance in South African culture, and at the association of Zulu with a martial masculinity. In exploring how Zulu has come to represent what is most properly and powerfully African, Sanders examines differences in English- and Zulu-language press coverage of an important trial, as well as the role of linguistic purism in xenophobic violence in South Africa. Through one person's efforts to learn the Zulu language, *Learning Zulu* explores how a language's history and politics influence all individuals in a multilingual society.

Duduza. Bopha. Imbiza. Phapha. Asixoliseni. Amapopeye . . . What is the power of a single word? Six days a week, advertising creative Melusi Tshabalala posts a Zulu word on his Everyday Zulu Facebook page and tells a story about it. His off-beat sense of humour, razor-sharp social observations and frank political commentary not only teaches his followers isiZulu but also offer insight into the world Melusi inhabits as a 21st century Zulu man. Over the past few months he has built up a big and a loyal following that include radio host Jenny Crwys-Williams and Afrikaans author Marita van der Vyfer. He pokes fun at our differences and makes us laugh at ourselves and each other. Melusi asks critical questions of everyone, from Aunty Helen, Dudu-Zille to Silili (Cyril Ramaphosa) and even Woolworths (why are their aircons always set on 'jou moer'?) His fans love him for his honesty and commitment to pointing out subtle and overt forms of prejudice and racism. Melusi's *Everyday Zulu* holds up a mirror that shows South African society in all its flaws and its sheer humanity. Most importantly, he shows the power of words and that there's um'zulu in all of us!

This book covers research findings on the language and education situations in Tanzania and South Africa. James Stuart was one of the most remarkable Natalians of his day. Though there was nothing outwardly spectacular about his career as a colonial official, in 25 years of single-minded labour he built up what is now regarded as the most valuable collection of African oral traditions in existence in southern Africa. As a magistrate in some of the remotest corners of the Natal colony in the 1890s and early 1900s. Stuart sought out old people who remembered the times of Dingane and Mpande, and whose fathers and mothers had been ruled by Shaka. Interviewing them in fluent Zulu, he painstakingly filled hundreds of notebooks with their reminiscences and the traditions which older generations had handed down to them. The statements which Stuart recorded from nearly 200 informants are now housed, together with his own writings on Zulu customs, language, and praise-poetry, in the Killie Campbell Africana Library in Durban. Since 1971 the department of Historical and Political Studies at the University of Natal, Pietermaritzburg, has been engaged in a project which aims to publish all the historical evidence collected by Stuart
